

## **The West-Wide Energy Corridor Draft Programmatic EIS**

The United States Department of Energy, the United States Department of the Interior Bureau of Land Management, the United States Department of Agriculture Forest Service, and United States Department of Defense (the Agencies) will prepare a **Programmatic Environmental Impact Statement (PEIS)** to evaluate issues associated with the **designation of energy corridors** on federal lands in eleven Western states. Based upon the information and analyses developed in this PEIS, each Agency would amend its respective land use plans by designating a series of energy corridors.

The following Corridors will intersect or are within 5 miles of the CDT:
